## **January Oregon Invasive Species Network Newsletter**

**WILDLIFE PACKAGE OFFICIALLY INTRODUCED AS HOUSE BILL 4148:** Representative Helm has introduced, for the 2024 Legislative Session, a Wildlife Package that prioritizes wildlife disease, invasive species, wildlife stewardship and coexistence, and wildlife corridors and road crossings. The Invasive Species Prevention and Response is focused on providing resources, securing funding, and assessing improvements of state programs and activities aimed at preventing

negative impacts or establishment of invasive species in Oregon. HB 4148 has earned bipartisan support across a broad coalition of conservationists and environmentalists.

HB 4148 is expected to become publicly viewable on the Oregon Legislative Information System (OLIS) on February 2nd, where members of the public can submit testimony and track the bill's progress.
