Deschutes County Noxious Weed Program (Kevin Moriarty, Deschutes County)

- What can OISC do to help with getting noxious weed information out?
 - Videos and printable materials from the council would be valuable to have printable info to provide to stakeholders with a focus on the A and B listed species could be used in upcoming workshops on how these invasives spread

Eurasian Watermilfoil Past, Present and ? (Bill Reynolds, Confederated Tribes of the Warm Springs)

- Future funding efforts?
 - Park ranger managers reality is that they have no capacity but if we could find a willing land owner to lead the effort
 - Tribal ramp gets low use vs other launches
- boat wash stations?
 - Have we considered using contractors? FS contracts for weed wash stations and they do everything
 - OWEB Focused Investment Partnership -> possibility for funding
 - Consideration for subcommittee/working group
 - Boat wash considerations: power, water and disposal for wash water and EWM (dumpster), cost of maintenance, staffing

Oregon Rangeland Monitoring: Local partners working together to assess landscape scale restoration effectiveness (Jackie Cupples, *USFWS*)

 - Biggest issue now is funding for the field crews such a large scale of the amount of
 work in terms of treating invasives ideas or strategies for advancing capacity for field
 crews and making sure they have enough crew members would be helpful
 - Council doesn't have funding but we might be able to help with training and resources

Bullfrog control on the Little Deschutes River (Jodi Wilmouth, 3 Rivers Environmental)

- What are the negative impacts to the landowner for letting Jodi and her team remove bullfrogs on their land?
 - Most people just don't want fed gov involvement the biggest issue is that it is a fed funded project and many don't want that on their land — especially when the Oregon spotted frog (ESA species) is involved
 - Use other landowners/ community involvement to help build relationships with those that don't want their team on their land

Transboundary Feral Swine Working Group (Heidi McMaster, Reclamation)

- Current feral swine distribution?
 - Map of the feral swine is very out of date and only shows whether they are present in a county
- Squeal on Pigs has a new app

Metolius Invasion (Maret Pajutee and Beth Johnson, USDA FS, Sisters Ranger District)

- Difference between variegated and non-variegated cultivars?
 - Ribbon and the reed canary grass are related
- Has there been outreach to fly fishermen and hikers?
 - Yes but more outreach is needed to have fisherman clean their gear
- Ribbon grass is still sold in plant nurseries it's a nomenclature issue, if its called anything else then its not listed as invasive species
